LENGTHS & CONDITIONS OF THE LIMITED WARRANTY

This Limited Warranty starts on the date of purchase. To determine the length of this warranty, refer to the product's "Law Label" code and the corresponding warranty period listed herein. If a manufacturing defect occurs during the warranty period, Springwall will repair or replace (at Springwall's option) the defective mattress and/or foundation. If replacement is required, Springwall may substitute materials of equal or higher quality if the like components are NOT available. Except for such repair or replacement; Springwall is not responsible for any transportation costs, loss of use or any other claim. NOTE: Repair or replacement of a mattress and/or foundation does not extend this Limited Warranty nor begin a new warranty period.

THE SPRINGWALL® LIMITED WARRANTY IS VALID ONLY UNDER THE FOLLOWING CIRCUMSTANCES:

- 1. You must be the original purchasing consumer.
- 2. You must provide a copy of the original store purchase receipt clearly showing the date of purchase and the purchase price.
- 3. You must complete the Warranty Service Request Questionnaire.

THE SPRINGWALL® LIMITED WARRANTY DOES NOT COVER THE FOLLOWING:

- 1. The mattress or foundation fabric covering materials

- 4. Bent border wire due to mishandling.

- 8. Transportation charges to and from the factory.
- 9. Compensation for loss of use.

- 11. Sleep sets sold "As is", Floor Models or Samples.
- 12. Products sold for commercial or institutional use.

THIS WARRANTY WILL NOT APPLY IF THE MATTRESS OR FOUNDATION IS SUBJECTED TO ABUSE OR IMPROPER CARE SUCH AS, BUT NOT LIMITED TO:

- 1. Inadequate support from a weak or unsuitable foundation.
- 2. Inadequate support from an unsuitable frame, or bed.
- 3. Stains, soiling, burns.
- Excessive abuse or lack of care.
- 5. Upholstery compacting due to insufficient turning.
- 6. Use of a board between the mattress and foundation.
- 7. Use in an adjustable bed unless specified.
- 8. Any damage as a result of moving or other subsequent relocation.
- 9. Normal wear and tear, a gradual depreciation of support and comfort over time from regular use.

WHAT TO DO IF WARRANTY SERVICE IS CONSIDERED:

- 1. Contact the retailer where the mattress or foundation was purchased and complete a warranty questionnaire; review with the retailer.
- 2. Retailer may submit warranty questionnaire to Springwall for review, on your behalf.
- 4. Springwall product label and law label must be intact, and remain affixed to the bedding.
- Do not return mattress or a foundation (for repair) without specific instructions from an authorized Springwall representative or authorized retailer.

CARE FOR YOUR NEW SLEEP SET

- BODY IMPRESSIONS: The materials used in this mattress are designed to conform to your body's individual contours. Normal settling of materials is to be expected and is not structural or manufacturing defect.
- FOUNDATION: Do not use a foundation other than a matching one purchased with this mattress. It is the foundation that supports the entire mattress and a structurally inferior foundation can cause the mattress to collapse and voids the warranty.
- FRAME SUPPORT: A centre support is required. Double, Queen and King size sets require the use of a bed frame with a horizontal or vertical metal centre support and leg support. (see 1.2)
- 4. MOVING: Do not bend, fold or stand your mattress as internal damage may result. Do not stand or jump on the mattress. It is not built for that kind of weight concentration. By carrying a mattress on it's side, it is less likely to get damaged. It should be stored flat. Should your mattress have handles; they are to be used for positioning only. They are not designed for carrying or lifting.

IMPORTANT CARE INSTRUCTIONS

The mattress must be continuously supported by a matching (or equivalent) foundation and used with an appropriate frame with centre and leg support. A bed requires a minimum of 5 cross slats (1 " X 4") with 3 concentrated in the centre third for double, queen and king sizes as well as longitudinal central beam with a centre leg support.

HOW TO CARE FOR THE MATTRESS

- 1. Rotate the mattress every month (as shown below 1.1) for the first 6 months, every 3 months thereafter.
- 2. Rotate foundation every 3 months.
- 3. Never bend an innerspring mattress.
- 4. Never bend a foam mattress more than 30 degrees.
- Use a quality bed frame. To avoid structural damage and voiding of your warranty, double, queen and king size sets must also be used with a rigid centre support with a leg.
- 6. Do not get the mattress wet.
- 7. Use a mattress encasement to keep the mattress clean and healthy.
- 8. If you purchased a mattress only, it must be supported by an acceptable foundation or bed frame that prevents the mattress from bending/bowing.
- 9. Do not use an iron or excessive heat on the mattress.
